Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

There will be no food at this trial. There are eating establishments on Hwy. 70 approximately 8 miles from the club.

**As crating space is limited please bring stackable crates if possible. NO X-Pens will be allowed. No crates allowed overnight. Dogs not entered in the trial are NOT permitted on the grounds. Dogs must be crated or on leash when not in the ring or exercising outside.

NOTICE TO EXHIBITORS

Entry fees shall **not** be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge or barred from competition by action of the Show Committee. Refunds will be issued minus an administrative fee of \$5.00 per dog upon request to the trial secretary for a bitch coming in season after the closing date of entries, provided *the secretary is notified prior to the date of the trial*.

ALL DOGS SHOULD BE PRESENT at least 30 minutes prior to Judging. The handler is solely responsible for having the dog at ringside. The steward *will not search for you*.

Exhibitors will be responsible for picking up after their own dogs. Once identified, those who do not pick up after their dogs will be excused from the trial WITHOUT refund. Please help us keep the show grounds and motel grounds clean. CHILDREN must be accompanied by an adult and under control at all times.

Footwear: Closed-toe footwear is required for exhibitors.

Liability: Sarasota Obedience Training Club and its agents, employees, etc., will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their

dogs or property and further assumes no responsibility for injury to children. SOTC reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against SOTC or any official thereof.

NO EXCEPTIONS! ENTRIES MUST BE RECEIVED BY THIS DATE.

No hand deliveries. Fax, Email or unsigned entries cannot be accepted. **Express Mail** entries must be clearly marked "**NO SIGNATURE REQUIRED**". All entries must be legible and filled out completely.

ENTRIES ARE LIMITED and will be taken on first come first served basis. Entries must be submitted using the most current official UKC entry form. A copy is included in the premium. An entry form with fillable fields can be found at: Nosework Entry Form.

Submitting Entries:

- Exhibitors may enter more than one dog but may handle only one dog in each level per element of the Trial.
- In the Nosework Trials section of the entry form, enter the appropriate Section, "A" or "B"; you must enter B if you teach nose work OR if you've earned a title at the level in which you are entered, in another venue. You may enter "A" if you are new to this level or do not teach.
- United Sarasota Obedience and Training Club reserves the right to return incomplete, incorrectly filled out or unsigned entries.
- Pre-entries must be mailed to the Trial Secretary.
- There will be no Day of Entries at these trials.
- Use a separate entry form for each dog entered in this event.
- · Note: Entry checks will be deposited just after entry closing date.

Waiting List: United Sarasota Obedience Training Club is offering a Waiting List to fill openings created by entries that are withdrawn after the trial's closing. A maximum of 25 entries per trial will be placed on the Waiting List. All entries, including wait-listed entries, must be received by the Trial Secretary prior to the trial's closing. If a withdrawn entry is replaced by a wait-listed entry, a full refund will be issued for the withdrawn entry. Any wait-listed entry that does not move off the Waiting List into the trial will receive a full refund. Withdrawn entries that are not replaced by a wait-listed entry will not receive a refund.

Any changes to entries, including cancelations, will be accepted until 5 p.m. on the date pre-entries end. Changes (including substitutions) must be made to the Secretary by e-mail, or in writing. Cancellations received after 5 p.m. on the date pre-entries end will not be eligible for a refund of fees. Receipt of entry will be acknowledged vial email, phone or mail (if self-addressed, stamped envelope is included). A follow-up information email will be sent after pre-entry period ends.

JUDGING SCHEDULE

Saturday, October 31, 2020

Check in begins at 8 a.m. A Judge's briefing will begin at 9 a.m. Judging begins soon after.

Order of Elements: The order of elements and the judging schedule will be determined after entries have closed and will be sent by email to entrants who have provided a legible email address.

Sunday, November 1, 2020

Check in begins at 8 a.m. A Judge's briefing will begin at 9 a.m. Judging begins soon after.

Order of Elements: The order of elements and the judging schedule will be determined after entries have closed and will be sent by email to entrants who have provided a legible email address.

AWARDS

Placement ribbons will be offered First through Fourth in each element in the A and B Sections. A qualifying ribbon will be presented to all qualifiers.

New title rosettes will be awarded for new Element and overall Level titles.

CLASS TRANSFERS/ MOVE-UPS

Any request for a move-up or other class transfer must be in writing and presented to the Trial Secretary at least 45 minutes prior to the start of the trial.

Move-up forms for Sunday must be completed before the end of the Saturday trial. Exhibitors will need to print & bring these forms with them if they would like to move to a different level. The Trial Secretary will have forms available for transfer requests.

If a move up is required prior to the trial, they will be accepted until 6 p.m. March 20, 2020. **POSSESSION OF ODORS**: Owner/handlers may not be in possession of any target odor on the grounds of the trial site. There shall be no training on the grounds of the trial site, other than the designated warm-up area.

HANDLER'S BREIFING

The first Handler's Briefing will take place at 9 a.m. each day with the first dog in that class to run immediately thereafter. The Handler's Briefing will take place in view of the search area(s) prior to the start of each class. No dogs may be present during the Handler's Briefing.

SEARCH AREAS AND WEATHER CONDITIONS

All container and interior searches will take place indoors on matted, carpeted, tiled or concrete surfaces. All Exterior and vehicle searches will take place outdoors. Handlers should understand that outdoor searches will be conducted rain or shine, unless dangerous conditions are present (such as lightning or flooding). Comfortable, closed-toe footwear and water-resistant clothing are recommended.

Sarasota Obedience Training Club shall abide by the practices set forth by the CDC, Federal, State and City Governmental guidelines. This event is being held in a manner that emphasizes the safety of participants and the club will be taking all precautions necessary.

TRIAL GUIDELINES:

- 1. Club officials, participants are required to follow state, local and facility guidelines that apply to the area and site where the event is held.
- 2. Practice social distancing consistent with current guidelines
- 3. Avoid congregating to the extent possible
- 4. Masks are required inside the building
- 5. Plenty of sanitizer will be available
- 6. Consider wearing disposable or washable gloves
- 7. Wash hands as frequently as possible
- 8. Avoid shaking hands or hugging
- 9. Avoid touching dogs that are not yours
- 10. Avoid commonly used pens/pencils—Bring your own
- 11.Bring your own chairs
- 12.No food will be available at this trial. Bring your own
- 13. Signed Waiver of Liability/Informed Consent Covid-19 Waiver must be returned with entries. This is not an option.

Entering/Exiting the building: Front door will be entrance only; side doors exiting to the fenced area will be exit only. Crating will be marked for 6ft social distancing and exhibitors are required to abide by those markings. Reminder that all crates and chairs must be removed from the building both days of the trial. Absolutely no congregating around the ring or other areas in the building.

ALL ENTRIES MUST INCLUDE THE SIGNED WAIVER OR ENTRIES WILL NOT BE ACCEPTED INTO THE TRIAL

SOTC COVID-19 WAIVER
