Notice to Exhibitors

Entries close at Noon on September 30, 2020

Fax, Email or unsigned entries cannot be accepted. Entries not on an Official AKC Entry Form or photocopy of an entry form without the Agreement and Rules on the reverse side of the official AKC entry form are not valid. Express Mail entries must be clearly marked. NO SIGNATURE REQUIRED. Entries will be returned to sender if no one is present to sign for receipt of the express mail.

ALL ENTRIES MUST BE LEGIBLE AND FILLED OUT COMPLETELY, MUST INCLUDE AKC AGREEMENT PAGE AND JUMP HEIGHT IF ENTERED IN A CLASS THAT HAS JUMPS OR THEY WILL NOT BE ACCEPTED.

ENTRIES ARE LIMITED and will be taken on first come first served basis, (so get your entries in early).

Rally Entries Fees: Includes \$3.50 for AKC event recording fee and a \$3.00 event service fee for the first entry and a \$3.00 event service fee for each additional entry of the same dog each day. Entry fees are \$26.00 for the first entry each day regular class and \$16.00 for each additional entry of the same dog, same day (AKC Dog Show Rules Chapter 11, Section 2).

ENTRY FEES WILL NOT BE REFUNDED IN THE EVENT A DOG IS ABSENT, DISQUALIFIED, OR EXCUSED BY THE JUDGE OR VETERINARIAN, OR BARRED FROM COMPETITION BY THE TRIAL COMMITTEE. IF RIOTS, CIVIL DISTURBANCES, OR OTHER ACTS BEYOND THE CONTROL OF THE CLUB MAKES IT IMPOSSIBLE TO OPEN OR COMPLETE THE TRIAL, NO REFUND OF ENTRY FEES WILL BE GRANTED.

Bitches that come into season, after the closing date of the entries, may have the entry fee returned less \$5.00 per day– upon written request from the owner or handler on or before date of trial.

Dogs should be present at least one half hour before they are to be judged. The owner or handler is solely responsible for having their dog at ringside when it is due in the ring. Dogs not required for further judging may be excused.

Crating area will be limited to 20 crates in the morning and 20 crates in the afternoon. Once the closing date has passed a final schedule with arrival times will be sent to all exhibitors. We will be practicing CDC guidelines as well as County and State Guidelines for Social Distancing and safety protocols.

Dogs not entered in the trial are NOT permitted on the grounds.

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. 1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes; please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles
2. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.
3. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
4. Dogs listed in the **AKC Canine PartnersSM Program** may be eligible to enter all-breed AKC Obedience trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

1. Club officials, participants are required to follow state, local and facility guidelines that apply to the area and site where the event is held.
2. Practice social distancing consistent with current guidelines
3. Face Masks are required
4. Avoid congregating to the extent possible
5. Consider wearing masks when in close proximity to others
6. Plenty of sanitizer will be available
7. Consider wearing disposable or washable gloves
8. Wash hands as frequently as possible
9. Avoid shaking hands or hugging
10. Avoid touching dogs that are not yours
11. Avoid commonly used pens/pencils—Bring your own
12. Bring your own chairs
13. No food will be available at this trial. Bring your own
14. Signed Waiver of Liability/Informed Consent Covid-19 Waiver must be returned with entries. This is not an option.

Entering/Exiting the building: Side door will be entrance only; rear door exiting to the fenced area will be exit only. Crating will be marked for 6ft social distancing and exhibitors are required to abide by those markings. Reminder that all crates and chairs must be removed from the building both days of the trial. **Absolutely no congregating around the ring or other areas in the building.**
